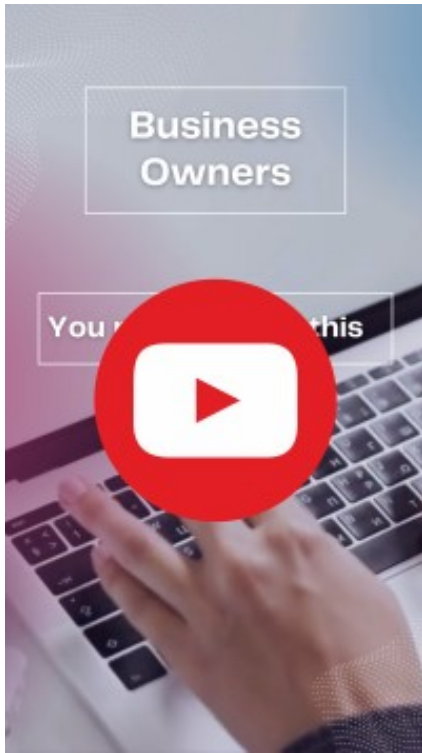

Payment Recovery Process

Signing Up

Step 1

Become a Member of the PMA & donate for the perk

Step 2

Member completes the data capture form, submits and checks the email confirmation to verify data is correct and complete

It's up to you how quickly this happens

The Admin Stuff

Step 3

The admin team gather the documents required and send pack to member for a wet-ink signature

Step 4

Member signs pack with a wet-ink signature and returns signed paperwork along with Passport

Allow us **4-6 weeks** for this part

Step 5

Bond is issued to Treasury

Step 6

1099 claim is sent to IRS.

IRS acknowledge claim by email.

Allow us **1-2 weeks** for this part

The Outcome

Step 7

IRS issue cheque if claim is successful

Step 8

Donate the agreed success fee

Repeat for the following year

Allow the IRS **26-35 weeks** for this part



We are responsible for submitting a claim but only the IRS are responsible for their decision to accept or reject a claim
